### Facebook Marketplace, Craigslist, and Private Landlords

- The Bozeman housing market is extremely competitive. Because many people will respond to each posting, it is common to not hear back after sending a message. While this can be discouraging, it is best to respond to as many postings as possible to increase your chances of hearing back.

## Housing Choice Vouchers

- Housing Choice Vouchers subsidize your rent, ensuring you pay no more than 30% of your monthly income toward your rent.
- Vouchers are administered by the Montana Department of Commerce, and HRDC has field agents who can assist you once you reach the top of the waitlist.
- Because these vouchers are associated with the tenant rather than a specific building, you have the choice to use the voucher on any properties that accept vouchers.
